STATE SELECTION AVAILABILITY FORM

CONDITIONS

1. State Selection Availability Form

- 1.1. This form is the means of advising Selectors of
- 1.2. your availability for state team selection and is not binding.
- 1.3. Confirmation of receipt of your availability form will be issued by the Chairman of Selectors with selection components and guidelines.
- 1.4. State Selection Availability due date:
 - 1.4.1. Tasmanian Veterans State Selection Availability Form is due **30th June 2024**.

2. Eligibility (note: for 2024 this Eligibility will only be enforced if there is competition for team places, but note as the event is scheduled to be held in Tasmania, there is likely to be a need for comparison results from playing in 2024 Open Tournaments held in Tasmania, to establish playing order in the various team options (A, B, C or Presidents) available).

- 2.1. Athletes must play in the current year a minimum of three recognised Tasmanian Open Tournaments (in the age group or below for which they are available) to have their availability for selection considered. If selection has not already occurred the Tasmanian Closed Tournament will count towards this requirement.
- 2.2. To be considered for selection the athlete must sign this Table Tennis Tasmanian State Selection Availability agreement and return it to the Chairman of Selectors by the date stipulated on the form.

3. Withdrawals

- 3.1. You may elect to withdraw your availability prior to the state selection date. This must be done in writing to the Chairman of Selectors. *Please refer to Section 4 National and State Emergencies*

4. National & State Emergencies

- 4.1. All national tournaments athletes will follow the rules and regulations set by the Table Tennis Tasmania (TTT) Board of Directors regarding national and state emergencies.
 - 4.1.1. Team Manager and Head Coach will be responsible for ensuring all rules and regulations are followed during national competitions. Ultimately though, it is the responsibility of all participants to adhere to the rules and guidelines.
 - 4.1.2. TTT Board will adhere to the rules and regulations set by Table Tennis Australia.

5. Funding Assistance

- 5.1. **Athletes must note that in the absence of any fundraising, athletes will be required to fund all costs associated with their membership of a team which includes interstate travel, accommodation, playing fees and uniform costs.**
- 5.2. All athletes are expected to participate and co-operate in all fundraising activities organised by Table Tennis Tasmania which directly or indirectly assists the funding of state teams.

 - 5.3. Please check with your affiliated association/club for any possible funding assistance.

5.4. Your City/Town Council may offer grants to players who are residents.

6. State Team Travel and Costs

6.1. As per *section 5 Funding Assistance*, all athletes will be responsible for their own costs and logistics.

6.1.1. Athletes are responsible for their own travel arrangements including, flights, accommodation, meals, and travel to and from the venue. **Athletes are responsible for all entry fees (Team and Individual Events) associated with the Championships.**

7. Residential Qualifications

7.1. To be eligible for state selection, an athlete must have resided continuously in Australia for 12 months, including in Tasmania as a registered player for at least 6 months prior to the commencement date of the national championships.

8. Compliance with Instructions

8.1. All intending players are required to comply with instructions as and when given by either State Selectors, Selectors on Tour, State Director of Coaching, Team Manager and Team Coaches.

8.2. Players who breach such instructions or are the subject of a Report may be summoned to appear before the State Selectors or a Disciplinary Tribunal.

9. Umpiring

9.1. Players may be required to undertake an approved umpiring test either before or after the selection of a team.

10. Team Selection

Teams are usually announced at the Tasmanian Open Championships each year.
